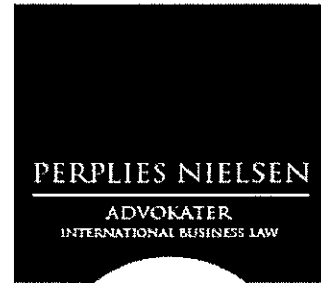

Re.: Termination and Cease and Desist

In reference to the multiple phone conversation and e-mail exchange of days past I hereby revert to you.

We have asked extensively you to explain the sudden and unlawful an unknown dealings in Sugar Loaf, without any satisfactory reply on your part. These dealings is only informed to us by third party and not previously by you, why our questions on these dealings are justified and appropriate.

We have been informed be third party that your actions has tied us to Remo Polselli, who our due diligence shows is a convicted felon in several financial schemes, and to Sugar Loaf – which we and OPI have no ties to nor do we want any ties to these apparent financial dubious dealings.

We have asked you politely several times in the last week to remove and disengage us from all connection to the abovementioned and LV Air, which you have not complied to.

We have yesterday been approached by a newspaper, who in fact sought our connection in Sugar Loaf, to which we have informed that we have no ties to Sugar Loaf nor because of your dealings do we wish to have any ties to you and /or LV Air.

Based on the confirmed by you information on your dealings with Mr. Polselli and your disregard for OPI proprietary information on the establishment of Las Vegas Air and Mr. Oscar Peters information, hereunder connections and dealings with various parties and projects made public on your Facebook page, and combined with your continuing lies about your connections with conflicted interests of OPI operations, which is further escalated by your falsified information and press releases on OPI's connection and dealings with you in

the Sun, we on this basis must termination any and all dealings, correspondence and collaborations with you, effected immediately.

This is further substantiated by the fact that you tried first to connect us falsified to Sugar Loaf to the Sun and not mentioning that you had – on our demands of being disengaged from this – tried to sell us the project; even though you had no legal claim and/or legal grounds to sell this property - To which we of course refused.

This means that any payment and/or agreements is in breach of contract due to your substantial damaging behavior and actions, among others your e-mails we have copies of, in which you imply your ability to “attack” OPI and it’s officers.


We will further hand the matter to our counsels, Fabiani and Lehane out of California, to take any and all legal actions against you to the fullest extent of the law.
